Controlling Weeds in Home Garden Asparagus Beds



The best time to control weeds in asparagus is early spring before the asparagus emerges. A light tilling (or hoeing) that is shallow enough to avoid the crowns will eliminate existing weeds. Many gardeners like to mix in organic matter during the same operation.

Herbicides can be used before asparagus emerges as well. Glyphosate (Roundup, Killzall) will kill weeds that are actively growing, and the preemergence herbicide trifluralin can be used to kill weed seeds as they germinate. Trifluralin is found in several products, but not all of them list asparagus on the label. Those that do have asparagus on the label include Miracle-Gro Weed Preventer Granules and Monterey Vegetable and Ornamental Weeder. Mulch can also be used to keep weeds from invading.

No herbicides can be used during harvest. The end of harvest presents another opportunity. Remove all fern and spears and apply glyphosate (Roundup) to control virtually all of the weeds present. After the harvest season is past and the asparagus starts to regrow, options are limited. Products that contain sethoxydim can be applied to asparagus to kill annual grassy weeds such as crabgrass. Sethoxydim has no effect on broadleaves including asparagus. Two sethoxydim products available to homeowners and labeled for asparagus are Monterey Grass Getter and Hi-Yield Grass Killer. With broadleaves, the only option is to pull them and look forward to next year. (Ward Upham)

EID Tags and Weigh-In

If you are unable to attend the tagging event, please contact the Extension Office to make arrangements to tag your animals. May 15 is the deadline to tag all market animals. No tag, no show, no sale.

Livestock Ownership

Dates for 2021 are as follows:

Market Steers & Market Heifers - owned and tagged by April 1

*Tags can be picked up at the Extension Office. Following tagging, photos of tagged animals must be submitted by April 1. The other option is to schedule a time with the Extension Office for Shandi or Shannon to come tag your animals. Must be done by April 1.

Breeding Heifers - owned by April 25

Bucket Calves - owned and tagged by May 8

Market Swine - born after Jan 1st, owned and tagged by May 8

Market Sheep - born after Jan 1st, owned and tagged by May 8

Market Goats - tagged by May 8

Rabbits & Poultry - owned by May 31

Fair Update

For 2021, showmanship will be judged by the specie judge as a class during the show. Members will need to pre-enter to participate in the showmanship class, round robin will be evaluated by a separate judge.

The Fair Board is hosting a 100th Fair kickoff with a performance by the Schmitz Blitz Band from 7:30-9:30pm, on Saturday, July 24th. Look for updates soon in regards to the 100th Fair!

All members must be enrolled in 4-H Online, exhibit each enrolled project at the Fair, and attend at least one half of regularly scheduled club meetings to complete the 4-H year.

Members who exhibit market steers, market heifers, market hogs, or market lambs, must meet the minimum weight requirements to be eligible to participate in the premium sale, or floor bids for their animals.

Market steers and heifers - 1000 # Market lambs - 100 # Market hogs - 220 #

Plan B Animals

Buyers for the livestock premium sale who plan to use plan B, will need to make arrangements at the locker of their choice. The Fair Board will not have an alternative locker location secured for these animals.

COVID Protocols

As you might know, Chase County commissioners have voted to opt out of the Governor's mask mandate. At this time, protocols at the State Extenstion Office remain the same. This requires any face to face 4-H related event to be approved by the extension office and state office, wear masks at all 4-H related events, and social distance. Approval has been obtained for face to face club meetings with masks and social distancing. For families uncomfortable with attending face to face meetings, leaders are asked to make a virtual attendance possible. 
