#### Foods Rule Change for Fair

As a reminder in 2023 there was a new Foods rule put in place. The new rule is as follows: For food safety purposes, any entries with frostings and fillings must calculate the amount of sugar in the frosting/filling recipe only. Calculation must be attached to entry, or the placing will be lowered one ribbon when judged. Frostings and fillings need to contain more than 65% sugar for safety. #### 4-H Livestock Sweepstakes

The 2024 Kansas 4-H Livestock Sweepstakes will be hosted on the K-State campus in Manhattan August 17-18.

All Kansas 4-H'ers are invited to participate in this livestock learning and competition experience. The Kansas 4-H Livestock Sweepstakes includes the state 4-H livestock judging contest, meat judging contest, livestock skillathon, and livestock quiz bowl in one action-packed weekend. 4-H'ers can test their knowledge and display their expertise in a variety of livestock-related events. This is also the qualifying event to select youth who will represent Kansas at each of the national 4-H contests. Awards will be given in each contest, in addition to overall Sweepstakes buckles to the team and individual placing the highest in all four contests!

All entries must be submitted online through local extension units by August 1. Contact local extension offices for entry information and/or details on local-level qualifying opportunities.

#### Kansas State Fair Grand Drive Entries

Reminder to Enter – <u>a complete nomination does **NOT** constitute show entry!</u> It only makes animals eligible to be entered into the Grand Drive or KJLS. Exhibitors must submit an official entry and pay the appropriate fees through each show directly. The Grand Drive and KJLS are independent organizations, so if you plan to participate in both shows, you will need to visit the entry link for both to submit entries for your kids. You will use the same ShoWorks account created for exhibitors at the time of nomination. When each show opens their entry link, they will be posted on their respective websites, as well as their social media platforms. Entries for the Grand Drive will most likely open early next week. So, check their website and Facebook page around July 1st.

#### Pullorum-Typhoid Testing for 2024

Kansas continues its designation as a Pullorum-Typhoid (P-T) clean state. With that being said the Kansas Department of Agriculture is able to decrease the required surveillance for PT testing. Routine surveillance testing will be performed for each county fair a minimum of once every 5 years. KDA has created a map designating the next time Chase and Morris Counties will need to be tested and that will be in 2025. If you have birds from in-state, you do not currently need to test for PT or provide proof of being from a certified PT clean flock this year for the County Fair this year and they come from out-of-state, you must show proof that they originated from a certified U.S. Pullorum-Typhoid clean flock or provide a negative PT test. Other poultry shows may still require a negative PT test to participate, this rule is only for your local county fair. This year, 2024, Tri-County Fair in Herington, KS will have a vet on staff to do testing if you are in need of it. The Kansas State Fair will require a negative PT test still and they will be offering testing at check-in. Please note that if P-T is discovered in the state, requirements could change. If you have questions, please reach out to the Extension Offices with any questions.

#### 2024 State 4-H Horticulture Judging Contest

The State 4-H Horticulture Judging Contest will be held on Saturday, August 10, 2024, in Manhattan, Kansas. Our contest is hosted for the day by the Department of Horticulture and Natural Resources.

Intermediates must be 9 thru 13 before January 1 of the current year. Seniors must be 14 thru 18 before January 1 of the current year.

The objective of 4-H Horticulture Judging is for members grow in their ability to think, to reason, and to make logical and scientific judgments, through plant identification, knowledge testing and judging classes.

Registration begins at 9:30am and Awards will conclude the day at 2pm

Cost per person will be \$18 per youth. More information about registration will be shared as soon as it is made available. If interested, please let the Extension Office know.

#### Biosecurity and Herdsmanship at County Fair

As the county fair approaches we have received numerous H5N1 Influenza A Virus in Dairy Cattle updates from Kansas State and the following statement was released from KSRE, Kelsey Nordyke, 4-H Ag Sciences Program Specialist:

"On Monday, April 22, the Kansas Animal Health Commissioner issued an order requiring special permits related to the movement of lactating dairy cattle due to H5N1. As a result you will need a valid Certificate of Veterinary Inspection (CVI) and the veterinarian completing the CVI must contact the Kansas Animal Health Commissioner to obtain a permit of type number to be included on the CVI form. Please contact your herd veterinarian at least 2 weeks prior to the show to obtain a valid CVI that covers the dates of the show. The current order does not require a CVI for dry cows or heifers as it only pertains to lactating dairy cattle. "

With this in mind here are the recommendations for all livestock exhibitors at the country fair from the Biosecurity Webinar I participated in from Dr. Sara McReynolds, Assistant Animal Health Commissioner.

- > Bring only HEALTHY animals to the county fair. Animals showing signs of sickness will be sent home by directions of the superintendent, agent and fair board.
- > Do not share feed or water buckets with other exhibitors
- ➤ Do not use a common water tank
- $\succ$  Make sure all areas and pens/cages are kept clean
- > Avoid nose to nose contact of animals as this is a higher risk.
- ➤ Practice good herdsmanship at all times
- o A true herdsman properly cares for their livestock, small animals, pens & equipment, ensures safety and to keep the animals and surrounding areas clean and attractive at all times.
- ➤ Remember: Someone is always watching! Siblings, Parents, Sponsors and Buyers.
- > Superintendents, Agents and Fairboard wish to ensure all have a great fair experience.

#### Fair Updates

Changes for the 2023-2024 4-H Year:

- Minimum weights for livestock-Market Beef 1000 lbs, Market Hogs 220 lbs, Market Lambs 100 lbs and Market Goats 50 lbs
- ♦ Fair Dates-July 18th-July 25th, 2024
- ♦ The Dog Show will take place on Friday, July 19th at 6 pm
- ♦ The Sheep/Goat Show will take place on Monday, July 22nd at 8:30 am. weigh-in will be after the horse show on Sunday at 7 pm.

#### NO livestock will be allowed prior to 7 pm!

- ♦ The Swine Show will still take place on Tuesday, July 23rd at 8:30 am and weigh-in will be Monday between 5:30 and 7 pm.
- More information on weigh-in times and schedule will come out as usual prior to fair.
- Premium money may be withheld if exhibits are removed before 11am without Fair Board approval.
- ♦ Horse Show will start at 4pm on Sunday, July 21st

#### Plan B Option

The Chase County Fair board has decided that moving forward the Plan B option at the Fair for the livestock sale will no longer be an option. Plan B is where the buyer can pay the premium and also purchase the animal to take to a locker. If a buyer would like to purchase the animal, they can do so but arrangements need to be made prior to the county fair with the 4-Her.

#### Photo Boards

Photo boards are available in the Extension Office. You will need to stop by and purchase them for each photo you will exhibit at the Fair. This year photo boards will be \$2 a piece. Please have exact change as we can not make change at the office.

#### Premium Livestock Sale Rule Change

A new rule has been made from the State 4-H Office stating that "Livestock are now eligible to be sold through a premium auction only sale, and youth are allowed to retain ownership and take them on to the Kansas State Fair and the Kansas Junior Livestock Sale." The Chase County Fair board voted to adopt this policy as well. Moving forward for the 2024 year, a 4-H member can sell their animal through the premium sale and retain ownership of that animal if they choose to or they still have the option to sell to the floor buyer. Youth can take that same animal on to the State Fair and KJLS. Youth who retain ownership of any beef will not be eligible to participate in the carcass contest. If a youth retains ownership of a market animal, that animal will not be allowed to be brought back to the county fair the next year to show again. The rule that all Grand Champion animals must sell has also been removed. All in all, the sale is no longer deemed a terminal sale. If you have any questions, please reach out to the Extension Office.

Rules: Each 4-Her will receive 10 tickets. Tickets are color coded for each club and are \$1 each this year. 

#### Premium Livestock Sale Rule Change

A new rule has been made from the State 4-H Office stating that "Livestock are now eligible to be sold through a premium auction only sale, and youth are allowed to retain ownership and take them on to the Kansas State Fair and the Kansas Junior Livestock Sale." Youth can take that same animal on to the State Fair and KJLS. The other rule is you are not allowed to bring that same animal back the next year as a breeding animal if it was shown as a market animal the previous year.
