Please complete your 4-H enrollment at 4-H Online (https://ks.4honline.com) as soon as possible! The deadline for enrollment/reenrollment completion is November 1st. The Extension Office will be happy to provide help to New Families or for those who do not have access to the internet, if the Club Leaders are unavailable to assist them. REMINDER: Starting this year, there is a \$15 annual enrollment fee for 4-H. However, if this is your first year, the Morris County 4-H Foundation will cover your fee. If you are a returning 4-Her and you turn in your record books; the Foundation will

also cover your fee. You can also apply for a waiver.

Volunteer Information Profiles (VIP)

Just like 4-H members, all volunteers need to "enroll" or "reenroll." K-State requires all direct 4-H volunteers to be registered **before** they can continue with their roles as club leaders or project leaders at a club, county, or district level.

If you have been an approved volunteer since 2014, then you needed to re-apply in 2017. If you were approved after 2014, and remained active, then you need to re-apply every three (3) years. In between, you are required to complete a renewal form at the same time as 4-H enrollment and due by November 1st annually.

Lisa has already handed out a few applications for those who have to reapply and renewal forms, but there is much work to be done to get caught back up on the process and maintain the requirements set forth by the State 4-H Office. For application forms or renewal forms, please contact your club leader, go to our website at http://www.flinthills.kstate.edu/4-h/morris-county/, or stop by the Extension Office. You can also log into your 4-H Online account when you enrolled for 4-H, and complete the process, or at least start it there. If you have any questions, please contact Lisa at palmer50@ksu.edu, call, or stop by the Extension Office.

Lisa will have information such as club status reports, new applications and renewals forms available at the upcoming Club & Project Leader Training on Monday, November 27. It is vital that you turn in your Project Leader Lists by Tuesday, November 14 so Lisa can have all the information she needs to prepare. Lisa will also be sending out e-mails ahead of time with information—so keep an eye out!

<u>Morris County Conservation</u> <u>District Senior High School</u> <u>Scholarship</u>

The Morris County Conservation District is offering a Senior High School Scholarship for \$500 again this year. Applicants must be pursuing a degree in a natural resource field. A 500 word essay explaining why conservation and water quality are important to them and how the scholarship will benefit them personally and professionally is required, must submit a copy of their school transcript and provide two letters of recommendation that are not relatives. **Deadline is December 22nd**, and recipient will be presented a medal at January 27th annual meeting. Kansas 4-H Scholarship

The Kansas 4-H Scholarship for the 2018-2019 academic year is now available our website at on http://www.flinthills.k-state.edu/4h/morris-county/ in a fillable form. Forms are also available in the Extension Office. Youth who should be applying for this scholarship should be in their Senior year in High School OR OLDER. All instructions are on the the first page of application. Scholarship selection is 90% based on 4-H merit of leadership, citizenship/community service, participation, recognition, and 10% on non-4-H related experiences. Completed applications need to be

submitted to Extension Office no later than Wednesday, January 24th.

<u>Citizenship In Action - Topeka</u> February 18-19, 2018

Citizenship in Action is for Kansas youth to learn how the state legislative process works and how their voice and participation in decision-making make can a difference in their communities. Delegates will tour the Capitol, get tips on how to meet and talk with their legislators, and discuss how youth can have a greater impact in their communities.

Sunday will feature time at the Capitol, legislative sessions, and a dinner and dance at the Capitol Plaza Hotel. Monday is reserved for delegates to meet with legislators.

Who Should Register?

Any youth 13-18 years old before January 1, 2018. 4-H membership is not required to attend. Registration is dependent upon Local Extension Staff approval.

Chaperones

All youth delegates must have a designated, VIP registered, adult chaperone who is at least 21 years of age. Chaperones will only be responsible for the number of youth delegates they are able to transport between the hotel and the Capitol building up to a maximum of 15 delegates. Chaperones must be with their delegates at all times.

Cost

\$170 includes: lodging, a banquet Sunday evening, formal breakfast, snacks and lunch for delegates and legislators on Monday, insurance, and program fees (i.e. printing, meeting room costs, etc.). There will be no refunds if cancelling after January 15. Cancellations before January 15 will result in a \$25 Cancellation Fee.

**Groups who wish to invite their legislators to the Sunday evening banquet at the hotel are encouraged to do so, but will need to RSVP to their Local Extension Unit and pay \$35 per guest. Youth who wish to have a bed to themselves can make that selection for an additional \$35 during registration. If you have a roommate request, both individuals MUST select the single bed option.

Attire

Dress for the event will be business attire. Ladies are recommended to wear a business suit with a jacket and a skirt or pants. Skirts must be at least knee length. Low-cut blouses and bare shoulders are not acceptable. Gentlemen should wear a business suit or slacks with a jacket and tie. Jeans are not appropriate at the Capitol or at dinner. Participants will

be walking all day; comfortable shoes are recommended (no tennis shoes!). The dress code is important and will be enforced.

Contacting Your Legislator

There are several opportunities for delegations to schedule visits with legislators on Monday morning or during lunch (all legislators will receive an invitation for lunch on Monday); or you can set up another time with your legislator. When contacting your legislator, make sure you remember: to be polite, be persistent and be concise.
